THE TRAVEL EXPECTATIONS FOR AN ACADEMY COACH / TEAM FOR GAMES ARE MINIMAL DUE TO THE PROXIMITY OF TEAMS IN THE YMCA LAKESHORE LEAGUE. THE LAKESHORE LEAGUE CONSISTS OF TEAMS FROM – PLYMOUTH, KIEL, SHEBOYGAN FALLS, OOSTBURG, KOHLER, CEDAR GROVE AND HOWARDS GROVE.

AN ACADEMY TEAM CAN PARTICIPATE IN AS MANY TOURNAMENTS AS THE PARENTS/ COACH AND PLAYERS ARE WILLING TO PARTICIPATE IN PER YEAR. TOURNAMENT COSTS ARE IN ADDITION TO THE SET ACADEMY FEES. PSC DOES NOT REQUIRE TEAMS TO PARTICIPATE IN TOURNAMENTS OTHER THAN THE PSC U10 TOURNAMENT IN EARLY JUNE. PSC DOES STRONGLY ENCOURAGE TEAMS TO PARTICIPATE IN THE BAVARIAN FESTIVAL GAMES (BOYS IN MAY, GIRLS IN OCTOBER) AS PART OF OUR AFFILIATION WITH THE BAVARIAN SOCCER CLUB.
